However, not all of the information displayed on the webpage has in-text citations. This makes one question where they got this information from.

The website informs the individual what they can do in order to have an assessment done; it informs who they need to get a referral from in order to have this assessment. However, this is from the American Occupational Therapists Association website, so some of the resources may not be applicable to the person in our case because she is from Canada. The website page informs how the assessment will be covered financially, however this will likely be a different process in Canada.

The website also provides references in case the reader would like to gain further knowledge about the Functional Capacity Evaluation.
